

Level 3 Qualification in Esports Leadership

Trailblazer Delivery Agreement

1. About this agreement

This agreement is for the organisation you are representing to pilot the Level 3 Qualification in Esports Leadership as part of the Esports leadership programme offered by the Leadership Skills Foundation. This agreement is solely for the terms and conditions for the pilot delivery of the qualification and programme. The Qualification Centre Terms and Conditions details the requirements and obligations of being a centre with the Leadership Skills Foundation.

This agreement comes into force when the centre accepts the Qualification Centre Terms and Conditions and its associated policies (see the policies page of our website for details).

Planning, delivery, training and assessment for the programme may commence on this date and continue until 31 July 2024 unless otherwise instructed by the Leadership Skills Foundation

2. Your agreed role as a centre in taking part in the pilot of the Esports leadership programme

As part of the pilot delivery, the centre must:

- 2.1. register as a Leadership Skills Foundation qualification centre;
- 2.2. adhere to the Qualification Centre Terms and Conditions and all associated policies;
- 2.3. appoint personnel to undertake the delivery of the qualification and ensure they are appropriately trained and experienced in Esports to deliver the Level 3 Qualification in Esports Leadership;
- 2.4. use the resources specified by the Leadership Skills Foundation and ensure their use is standardised across the centre's delivery team.
- 2.5. display the 'trailblazer centre for Esports leadership' (the centre will be referred to as this when delivering the programme) on their website, social media and internal paperwork to represent their involvement in the pilot;
- 2.6. collate feedback about the delivery and assessment of the programme when requested to by the Leadership Skills Foundation;
- 2.7. ensure the course content is delivered in future by the end of the pilot period;
- 2.8. ensure that Esports leaders (i.e. the learners) and participants in Esports activities only lead/play activities in games which are age appropriate to them;
- 2.9. participate in forums, focus groups and insight research projects, to help us develop the qualification and programme to meet centre and learner needs. By

signing up to become a 'trailblazer centre for Esports leadership', you are agreeing to be participate in such requests.

3. The agreed role of the Leadership Skills Foundation

To support the pilot of the programme, the Leadership Skills Programme will:

- 3.1. support the centre and learners as per the Qualification Centre Terms and Conditions and all associated policies (this includes centre approval, course administration, quality assurance and certification, and so on);
- 3.2. provide programme resources and training to deliver the Esports leadership programme;
- 3.3. arrange agreed intervention meetings, where required, to monitor progress and gather feedback on the programme with a view to making future improvements.

4. Agreement

This Agreement is part of the registration process for a centre to become a 'trailblazer centre for Esports leadership'. By agreeing to the Qualification Centre Terms and Conditions, and completing the Esports leadership registration form, the centre you are representing, and the Leadership Skills Foundation, agree to meet the roles and the payment terms agreed as outlined above.
